

**RESOLUTION NO. 100-2023**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH,  
PALM BEACH COUNTY, FLORIDA, PROVIDING FOR THE DESIGNATION  
AND/OR THE DE-DESIGNATION OF THE HISTORIC/SPECIMEN TREES AT  
1265 SOUTH OCEAN BOULEVARD AND 60 BLOSSOM WAY, PROVIDING AN  
EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Lignum Vitae (botanical name: Guaiacum Officinale) designated as a historic or specimen tree shall be removed from 1265 South Ocean Boulevard.

Section 2. The Pink Tabebuia (botanical name: Tabebuia Pallida) designated as a historic or specimen tree shall be relocated to the western property line.

Section 3. The Yellow Poinciana (botanical name: Peltophorum Pterocarpum) designated as a historic or specimen tree shall be removed from 60 Blossom Way and a relocated Yellow Poinciana (botanical name: Peltophorum Pterocarpum) from 1285 South Ocean Boulevard shall be added as a historic or specimen tree with the Palm Beach County Clerk:

**60 Blossom Way (PCN/Legal:50-43-44-02-12-000-0011)**
