RECREATION ADVISORY COMMISSION

The Recreation Advisory Commission consists of seven members serving three year terms, appointed by the Town Council. Members of the Commission shall possess a knowledge or interest in Town recreation programs and facilities. Each member of the Recreation Advisory Commission is required to be a registered voter in the Town. The Commission acts in an advisory capacity and shall make recommendations to the Town Council on matters relating to Town recreation programs and facilities. Preference is given to candidates who are enrolled or have their children enrolled in a Recreation Department program or are a regular participant or volunteer at a Town Recreation Department facility. Three alternate members may be appointed by the Town Council who shall serve when called upon by the Chair in the absence of any regular member.

The Recreation Advisory Commission meets six times per year on the first Wednesday in the months of January, March, May, September, and November. Meetings begin at 9:00 a.m. and are held in the Town Council Chambers located on the second floor of Town Hall at 360 South County Road, Palm Beach, Florida.

#1 – Why do I wish to be reappointed?

Overview:

I became an Alternate Member of the RAC in 2019. In 2021, I was elected to be a voting member and in 2023, I was elected Vice Chairman. My present term ends in 2024, so I would like to continue in my role as Vice Chairman serving under Chairman Grier Pressly.

Reasons on why I want to be reappointed:

 I have only been a voting member for three years and have really enjoyed being on the Commission especially because our recommendations are not only heard but implemented by Town staff. Specifically in my case, I have been a strong proponent of ensuring our Town Par 3 Golf course keeps up with its increased demand. In our meetings, I have strongly recommended additional parking, an improved putting green and renovation of the maintenance facility. All these ideas have been already accomplished and are/or in work.

I have been a strong voice for pickleball and tennis as well. It is gratifying to see that the Town again has listened and new pickleball courts will be built at Phipps and that many of the tennis amenities I and my fellow RAC members have recommended are being installed.

- 2. I am a Florida resident and have lived in Palm Beach since 2013. I want to continue to give my time and energy to the Town. I live around the corner from the Town Hall at 173 Peruvian Avenue.
- 3. I have had business and leadership positions my entire life and believe I can continue to be of value to the Commission:
 - a. Have been a senior Executive and Board Member at public and private companies, including positions as CEO and President
 - b. Have been President of a large country club outside Boston with an 18-hole golf course, dining, paddle tennis, shooting, swimming and tennis
 - c. Attained the rank of Captain in the US Navy and had two commands, one being a Commanding Officer of an Attack Jet Squadron during the first Persian Gulf War.

- d. Continue to serve and have served on numerous Company Boards (profit and non-profit) and large country club boards
- e. Have been President of my Condo Association here in Palm Beach for the past ten years
- f. Currently, have my own consulting firm, Mooring Partners LLP with an office at 205 Worth Avenue
- 4. Love sports and recreation here in Palm Beach:
 - a. Played tennis and squash in college at the Naval Academy
 - b. Nationally ranked tennis player in the 60's age bracket
 - c. Love golf as well and play locally especially at the Par 3
 - d. MOST IMPORTANTLY, use all the PB Recreation facilities
- 5. Finally, am a team player and like to work on problems with Committees

I have been on RAC as an Alternate member for two years and as a Voting member for three years. During this time, I have only missed one meeting and have provided hopefully sound advice to all the Town's recreation programs, but especially the town tennis and golf programs.
