STAFF RECOMMENDATION

Staff recommends the Town Council approve Resolution No. 056-2024, awarding RFQ No. 2024-11 for Civil Engineering to Mock, Roos & Associates, Inc., Kimley Horn and Associates, Inc. and Chen Moore and Associates, Inc. for a five-year period.

SUMMARY EXPLANATION/BACKGROUND

The previously awarded professional services agreements between the Town of Palm Beach and the firms awarded via RFQ No. 2019-13 for Civil Engineering Consultants have no remaining extensions or continuations and will expire in September 2024. Pursuant to State Statute, an awarded contract can only be awarded for a period of five (5) years. There are a few exceptions to the statute currently to include auditing firms due to lack of availability.

Town Procurement and Contract Management issued RFQ No. 2024-11 for Civil Engineering Consultants. Procurement performed outreach to known firms directly. The solicitation was advertised and broadcast on Bonfire and DemandStar to 5,580 unique accounts registered as providers of professional engineering services. This project was also advertised on the Public Purchase Website, the Town Website, and the Palm Beach Post. The Town received ten (10) submissions, which were found to be responsive to the requirements of the solicitation.

The Selection Committee was charged with evaluating all submitted qualifications in strict accordance with the evaluation criteria set forth in RFQ No. 2024-11 Civil Engineering Consultants and independently scoring each proposer's qualifications.

The Selection Committee did not recommend the Procurement arrange for presentations or interviews of the top ranked firms due to a clear delineation in the level of qualifications submitted by firms.

The recommendation of the Selection Committee was to engage the incumbents, Mock, Roos & Associates, Inc., Kimley Horn and Associates, Inc., and Chen Moore and Associates, Inc. due to their successful completion of relevant projects, demonstrated understanding of the Town's unique needs and the extensive knowledge of prior, ongoing, and upcoming projects.
