

III. ARCHITECTURAL & HISTORICAL INFORMATION

Typical of many Palm Beach buildings, this two-story Mediterranean Revival style residence consists of simple rectilinear masses highlighted by arched window openings, stone ornamentation and balconies decorated with wrought-iron balustrades. The asymetrically massed primary facade (east face) consists of two major sections.

The main block of the house (the southern 2/3's) features a number of interesting details. The most striking is the amber leaded glass which forms an unusual star-pattern that is set into the arched openings of the first floor (this glass is repeated on the south and west facades). The main block also features carved oak entrance doors set into a decorative cast stone surround high-lighted with fanciful animal and human forms in bas relief. All windows and the small balcony are accentuated with stone lintels supported by decorative brackets.

The smaller north block gives the impression of being much taller than the adjoining main section. In addition to the two floors of living space at this end of the house a double garage has been carved out at the ground level. A balcony, with wrought-iron balustrade, appears over the garage with access provided by two sets of French doors decorated with the same leaded glass design as found in the main block. Stone lintels, brackets and columns are utilized extensively.

The plan of the house is basically "U" shaped and incorporates the customary Palm Beach courtyard. The courtyard is surrounded by a high wall, finished in the same rough-finished stucco of the house.

Casa De Los Arcos was constructed in 1924 at an estimated cost of \$48,000 from plans prepared by Marion Sims Wyeth (1889-1982), a Princeton graduate and Beaux-Arts - trained architect who came to Palm Beach in 1919 (see Appendix). Wyeth and Addison Mizner virtually monopolized the Palm Beach market for large villas during the early 1920's with Wyeth's list of clients including E. F. Hutton, John S. Pillsbury, James P. Donahue, E. T. Stotesbury, and many others. He also served as Joseph Urban's associate during

the construction of Mar-a-Lago, Marjorie Merriweather Post's lavish Palm Beach estate. Wyeth's Palm Beach career exceeded fifty (50) years and he had been credited with helping create the "Palm Beach Style" of architecture with his work gracing almost every street in town.

IV. STATEMENT OF SIGNIFICANCE & CRITERIA FOR DESIGNATION

STATEMENT OF SIGNIFICANCE

Casa De Los Arcos, located at 70 Middle Road, is a fine example of the Mediterranean Revival style of architecture which was popularized during the 1920's Florida Land Boom and is now equated with Palm Beach. The house was designed by one of Palm Beach's most noted architects, Marion Sims Wyeth, and exhibits his grasp of the style of the day.

CRITERIA FOR DESIGNATION

Section 16-38 of the Code of Ordinances for the Town of Palm Beach, Florida, outlines the criteria for designation of a landmark or landmark site and suggests that at least one of the criteria be met to justify the designation. Listed below is the designation criteria and justification for designation:

a) "Exemplifies or reflects the broad cultural, political, economic or social history of the nation, state, county or town."

Casa De Los Arcos was constructed during the height of the 1920's Florida Land Boom which is generally recognized as the birth of the modern-day Palm Beach resort, a resort known world-wide.

- b) "Is identified with historic personages or with important events in national, state or local history."

 Not applicable.
- c) "Embodies distinguishing characteristics of an architectural type or is a specimen inherently valuable for the study of a period, style, method of construction or use of indigenous materials or craftsmanship."

This residence is a fine example of the Mediterranean Revival style of architectural popularized by the talented

architects of Palm Beach. This style was to become the hallmark for architecture during the infamous Florida Land Boom and was copied far and wide.

d) "Is representative of the notable work of a master builder designer or architect whose individual ability has been recognized or who influenced his age."

The design for Casa De Los Arcos was the work of Marion Sims Wyeth who has long been recognized as one of Palm Beach's most important architects. His impact on Palm Beach has been tremendous with his local career extending for more than 50 years. Wyeth, was among the group of early 20th Century architects to utilize the Mediterranean Revival style of architecture which became so popular during the 1920's.

APPENDIX

Marion Sims Wyeth, of Palm Beach, architect and member of the firm of Wyeth, King and Johnson, established practice in that city after many years of professional experience in New York, where he still maintains a business address. He has been a significant influence in the upbuilding of his home community in recent years, and is one of the best-known professional men in the region.

Son of Dr. John Allan and Florence Nightingale (Sims) Wyeth of New York, Marion Sims Wyeth was born in that city on February 18, 1889. He attended local schools, graduated from Lawrenceville School in 1906, and from Princeton University four years later, with the degree of Bachelor of Arts. From 1910 to 1914, he prepared himself for his chosen profession through studies at the Beaux Arts in Paris. During 1914-1915, he served as private secretary to Thomas Nelson Page, in Rome, and returning to the United States in the latter year, began practice of his profession.

His first professional connection was with Bertram Grosvenor Goodhue, in New York City, and the next year be became identified with Carrere and Hastings. From 1919 until 1932, Mr. Wyeth practiced independently. He has continued to maintain offices in New York, at 37 East 57th Street.

Since 1932 Mr. Wyeth has been a partner in his present firm, earlier known as Wyeth and King, and now as Wyeth, King and Johnson. He became a partner in Florida Associates in 1942, and in Southern Associates in 1944. His professional experience in the Peninsula State has included construction of airports, hospitals, and Army and Navy facilities. He is a member of the American Institute of Architects, the Society of Beaux Arts Architects, and the Florida Association of Architects.

Active in the community life of the region which he has chosen as his home, Mr. Wyeth was a member of the board of directors of the Good Samaritan Hospital in West Palm Beach. He has served as chairman of the board of the large Polyclinic Hospital in New York City, so has had ample experience in this aspect of hospital administration and welfare work. He is a member of the Seminole, Everglades, and Bath and Tennis clubs of Palm Beach, and the Knickerbocker Club, Princeton Club and Century Association in New York. In his politics, Mr. Wyeth is a Democrat.

On November 25, 1915, Marion Sims Wyeth married Eleanor Orr, and they are the parents of four children: 1. Florence Nightingale. 2. Alice Eleanor. 3. Joan Allan. 4. Marion Sims. The family resides on Woodbridge Road, Palm Beach, and Mr. Wyeth's professional offices are in the Wyeth Building.
