## **STAFF RECOMMENDATION**

Staff recommends that the Town Council consider the request from contractor Russell Palmieri with PalmCorp Construction Services, Inc., regarding a time extension in which to complete the new construction of a new single-family home located at 234 List Rd. The contractor explains the need for extension in detail in their letter dated October 2, 2024. They are requesting ninety (90) days – with work to be complete by January 12, 2025.

## **GENERAL INFORMATION**

The property is owned by Valley Property Management, LLC. The property was purchased in February of 2022. The permit for new construction was issued on February 2, 2023, and based on the size of the home the contractor was given (20) twenty-months for completion. Expiration date, October 14, 2024. Per the contractor's letter dated October 2, 2024, the interior of the house is substantially complete however the owner decided to replace the pool that was installed. They also applied to ARCOM to add a pergola on the back porch which was not approved. Both processes took a couple of months. The pool is currently under construction. The delay of having to go to ARCOM and some weather delays is the main reason for the permit extension request.

The applicant appears to have complied with all new requirements for neighbor notice.

1. Provide a detailed letter explaining the reasons why a time extension is being requested.
2. Provide a construction schedule to show completion timeline (CPM, Gantt Chart).
3. Provide nuisance mitigation measures.
4. Provide a statement that first class mailed notice to neighbors within 300 feet will be provided at least 25 days prior to the meeting at which the extension is to be considered.
5. Include a copy of the above notification to neighbors. Be sure to include the meeting date in the letter to neighbors.
6. Provide a USPS Certificate of Mailing as proof of the mailed notice.
7. Payment – provide a copy of the receipt showing payment of all applicable fees (1% of remaining, unfinished construction plus technology fee).



I am as anxious as everybody else to bring this project to a successful conclusion. Thank you for your cooperation.




