




General Changes to Building Massing


- Lowered main building ridge height by 2'-0" (5%)
- Lowered height of North Wing by 2'-8" (7%)
- Reconfigured roof at north end of Entry Loggia
- Lowered and reconfigured roofs at Southeast Stairs by up to 5'-3"
- Reconfigured Bridge to reduce vehicle clearances at rear parking lot (20% reduction in underpass opening)

Changes to Detailing and Aesthetics

- Calibration of FEC arch and column hierarchies with historic main hotel building
- Additional detailing and screening elements added at north façade to screen equipment areas
- Refinements to balance proportionate scale of FEC façade elements within the Classical canon
- Refinement of details and material choices to reflect the local context of Mediterranean
