We are a community of friends and neighbors who take great pride in our enclave which celebrates the traditions of old Palm Beach. Our sidewalks allow us and our children and their children to walk from house to house freely and easily. Often the enthusiastic cyclist is seen wobbling about sometimes with dogs in tow. We are very privileged to experience the blessings of "neighborhood", a concept which is fast disappearing in this modern world. This alone justifies the rather large taxes we pay year after year. We know we are well protected and looked after by our town. Please do not disregard the value in the quiet which is precious to us all. The island has suffered enough these last 13 months with the changes in traffic both on our roads, the bridges, and the rerouting of airplanes... Please honor your devoted citizens some of whom have been here on the island long before any of this began. I grew up coming to Palm Beach over 40 years ago and have maintained a house here for my own family to know the carefree lifestyle that we so appreciate.

Introducing valet parking into our streets which would allow for numerous cars to drive up and down beginning as early as 5:30pm would endanger all those who stroll in front of our houses walking dogs and teaching little children to bike...

We are a residential area. It is highly inappropriate to permit this kind of circulation on our streets. The Supper Club may be a nice addition to the island and also provide income to the town, but it shouldn't be at the expense of those who have been regular tax payers for so many years.

This is a terrible injustice to your citizens and will impact us dramatically. The value of our homes will be hugely impacted, and an entire community which was quite unique is at risk of being overrun with noise, chaos, and a total invasion of privacy. The houses that line the Sea Streets are exposed to the activities in the streets. These are not the larger properties of the Estate Section or the North end. Please do not disregard how vulnerable we are and how drastically this would effect us all.
