RESOLUTION NO. 11-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE PURCHASE OF ONE 2018 PIERCE CUSTOM PUMPER AND ONE 2018 PIERCE AERIAL LADDER WITH NFPA DEPARTMENT REQUIRED EQUIPMENT, FROM PIERCE MANUFACTURING, INC., FOR THE AMOUNT OF \$1,064,613.00, WHICH INCLUDES A ONE HUNDRED PERCENT (100%) PRE-PAYMENT DISCOUNT OF \$55,998.00, IN ACCORDANCE WITH FLORIDA SHERIFF'S ASSOCIATION BID 16-VEF12.0, SPECIFICATION NO. 9 AND 19, AND THE TRANSFER OF \$19,613 FROM THE EQUIPMENT REPLACEMENT FUND CONTINGENCY, AND HEREBY ESTABLISHING A TOTAL BUDGET OF \$1,079,613.00.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, FLORIDA:

Section 1: The Florida Sheriffs Association Bid No. 16-VEF12.0 for the purchase of one 2018 Pierce Enforcer Custom Pumper Spec#19, plus options and one 2018 Pierce Enforcer Aerial Ladder Spec #9 with NFPA department required equipment options for the lump sum bid amount of \$1,064,613.00 is hereby awarded pursuant to attached Exhibit A and, establishing a total budget of \$1,079,613.00.

Section 2: The Town Manager is hereby authorized to execute a contract on behalf of the Town of Palm Beach for the purchase of one 2018 Pierce Enforcer Custom Pumper Spec#19, plus options, and one 2018 Pierce Enforcer Aerial Ladder spec #9 with NFPA department required equipment in accordance with the terms set forth above pursuant to the Florida Sheriff's Association Bid No. 16-VEF 12.0, Specification No. 9 and 19 as referenced in Section 1 above.

Section 3. The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the purchase of one 2018 Pierce Enforcer Custom Pumper Spec#19 and one 2018 Pierce Enforcer Aerial Ladder spec #9 with NFPA department required equipment in accordance with the terms set forth above.
