Brief Description	<p>Dear Town Council, I am opposed to the use of the former restaurant site being used as a private club for the following reasons: 1. A private club is not in compliance with the Town Code's C-TS . 2. A private club is not in compliance with Sec. 134-1106. 3. A private club, unlike a restaurant, would have events that members would come and leave at the same time in a lot of cases. 4. Dangerous to place club on our main North-South artery in town with an inability to stack cars. 5. Extreme hardship on Sea Street residents trying to exit their streets onto County Road which is already challenged with traffic going to The Rec Center and Palm Beach Day School. 6. Members of a club who choose not to valet would pour onto the adjacent Sea Streets to park. 7. The proposed club isn't town serving in that it is not a drug store, vacuum cleaning store, a bank, a gas station,etc. and would exceed the Code's limit of 3000 sq. ft. by 8,164 square feet. 8. You can't fit a square into a circle because by doing so violates our Town Code which is in place for very legitimate reasons.</p>
