

RESOLUTION NO. 62 -2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE PURCHASE OF ONE FORD F450 TYPE 1 MEDIUM DUTY AMBULANCE SPEC #1; PURCHASE IN ACCORDANCE WITH FLORIDA SHERIFF'S ASSOCIATION BID FSA16-VEF12.0 WITH NFPA DEPARTMENT AMBULANCE REQUIRED EQUIPMENT IN THE AMOUNT OF \$276,597.00 AND ESTABLISHING A TOTAL BUDGET OF \$282,597.00

WHEREAS, there is a need to replace the 2008 Horton Freightliner Ambulance; and

WHEREAS, during the Fiscal Year 2018 budget process a quote was obtained for the replacement of said equipment in the amount of \$276,597.00; and

WHEREAS, there is currently only \$274,625.00 in the equipment replacement account; and

WHEREAS, there is a need to transfer \$7,972 from the Fiscal Year 2017 Equipment Replacement Fund contingency fund in order to accommodate this purchase.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, FLORIDA:

Section 1. The Town Council authorizes the purchase of one Ford F450 Type I Medium Duty Ambulance spec#1; purchase in accordance with Florida Sherriff's Association Bid FSA16-VEF12.0 with NFPA department ambulance required equipment in the amount of \$276,597.00 and establishing a total budget of \$282, 597.00.

Section 2. The Town Council of the Town of Palm Beach hereby approves the transfer of \$7,972 from the Fiscal Year 2017 Equipment Replacement Fund Contingency to the Equipment Replacement Account.

Section 3. The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate this transfer of funds from the FY2017 Equipment Replacement Fund Contingency to the Equipment Replacement Account.
