## **RESOLUTION NO. 73 - 2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AWARDING RFP NO. 2018-17 FOR THE PROVISION OF WIFI SERVICES AND RELATED INFRASTRUCTURE AND EQUIPMENT FOR THE TOWN DOCKS TO BEACON WIFI TECHNOLOGIES, LLC, APPROVING A PURCHASE ORDER FOR INSTALLATION IN THE AMOUNT OF \$37,735 AND ESTABLISHING A PROJECT BUDGET OF \$41,500 AND INTERNET SERVICE SUBJECT TO FUTURE BUDGET APPOVAL AND AUTHORIZING THE TOWN MANAGER TO EXECUTE THE SAME ON BEHALF OF THE TOWN.

**WHEREAS,** The existing wifi solution at the Town Docks is insufficient to meet the needs of the patrons which utilize the services at this; and

**WHEREAS,** The Town Council of Palm Beach approved the expenditure of funds within the approved budget for fiscal year 2018 to correct this deficiency; and

**WHEREAS,** Beacon WiFi Technologies, LLC., was ranked the most favorably by the Selection Committee and received all positive references; and

**WHEREAS,** the Town of Palm Beach wishes to award RFP No. 2018-17 wifi services for the Town Docks to Beacon WiFi Technologies, LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1: The Town Council of the Town of Palm Beach hereby awards RFP No. 2018-17 and approves a purchase order to Beacon WiFi Technologies, LLC, in the amount of \$37,735 for the installation of a wifi solution at the Town Docks, establishing a project budget of \$41,500 and providing for internet service, subject to future budget approval.

<u>Section 2:</u> The Town Manager is hereby authorized to execute the purchase order on behalf of the Town.

<u>Section 3:</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the completion of the said project work, including any necessary change order work.
