RESOLUTION NO. 115-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, PROVIDING AUTHORIZATION FOR A CONTRACT EXTENSION FOR THE WORTH AVENUE COMMERCIAL DISTRICT MAINTENANCE PROGRAM TO BATTALAN ENTERPRISES DBA PROPERTY WORKS, IN AN AMOUNT NOT-TO-EXCEED \$154,402 AND ESTABLISHING A PROJECT BUDGET OF \$167,800 FOR THE WORTH AVENUE COMMERCIAL DISTRICT MAINTENANCE PROGRAM WHICH IS A NON-AD VALOREM ASSESSMENT PAID FOR BY THE PROPERTY OWNERS WITHIN THE ASSESSMENT AREA.

BE IT RESOLVED BY THE TOWN COUNCIL of the Town of Palm Beach, Palm Beach County, Florida as follows:

WHEREAS, a contract was awarded on June 6, 2016, to Battalan Enterprises dba Property Works for the Worth Avenue Commercial District Maintenance Program; a copy of which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, vendor has agreed to an extension of the terms and conditions of the said contract, which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, Battalan Enterprises dba Property Works has provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve (12) month extensions.

NOW, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

<u>Section 1.</u> The Town Council of the Town of Palm Beach hereby authorizes a contract extension to Battalan Enterprises dba Property Works for the Worth Avenue Commercial District Maintenance Program in a not-to-exceed amount of \$154,402 and establishes a project budget of \$167,800.

<u>Section 2.</u> The Town Manager is hereby authorized to execute this second (2) contract extension on behalf of the Town of Palm Beach for these services.

<u>Section 3.</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the completion of the said services, including any necessary change order work as recommended by the Public Works Director.
