

SECTION 3. The Town Council hereby authorizes the expenditure from the Utilities Department Chemicals - Wastewater Account (400.60.148.535-55210).



NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.


