## **RESOLUTION NO. 158-2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CONTRACT EXTENSION AND PURCHASE ORDER FOR STREET LIGHT AND SIGN POST PAINTING SERVICES TO ROOF PAINTING BY HARTZELL IN THE AMOUNT OF \$38,215, AND ESTABLISHING A PROJECT BUDGET OF \$43,950 FOR FY2019. THE REMAINING ONE YEAR PROJECT BUDGET SHALL BE \$43,950 WHICH INCLUDES AN ANNUAL COST OF \$38,215, AND A \$5,735 CONTINGENCY, CONTINGENT ON FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on July 8, 2015 to Roof Painting by Hartzell to provide street light and sign pole painting services to the Town of Palm Beach, a copy of which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, Roof Painting by Hartzell has agreed to an extension of the terms and conditions of said contract, and Roof Painting by Hartzell acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, Roof Painting by Hartzell has provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA as follows:

Section 1. The Street Light and Sign Painting Services contract for a twelve-month period is hereby awarded to Roof Painting by Hartzell for the amount of \$38,215 and establishes a project budget of \$43,950 for FY2019, contingent upon funding in the budget. The remaining extension for the following year shall be approved only upon satisfactory performance as determined in the sole discretion of the Public Works Director for an additional amount of \$43,950, contingent upon funding in future fiscal years.

<u>Section 2.</u> The Town Manager is hereby authorized to execute this contract on behalf of the Town of Palm Beach for this improvement.

<u>Section 3.</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the completion of the said project work, including any necessary change order work, as recommended by the Public Works Director.
