## **RESOLUTION NO. 157-2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CONTRACT EXTENSION AND PURCHASE ORDER FOR HOLIDAY LIGHTING AND DECORATION SERVICES TO FLORIDA CDI, LLC/CHRISTMAS DESIGNERS, INC., IN THE AMOUNT OF \$89,545.33, AND ESTABLISHING A PROJECT BUDGET OF \$102,980 FOR FY2019. THE REMAINING THREE YEAR PROJECT BUDGET SHALL BE \$308,940, WHICH INCLUDES AN ANNUAL COST OF \$89,545.33 AND A \$40,304.01 CONTINGENCY, CONTINGENT OF FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on July 12, 2017, to Florida CDI, LLC/Christmas Designers, Inc. for the Holiday Lighting and Decoration Services to the Town of Palm Beach; a copy of which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, Florida CDI, LLC/Christmas Designers, Inc. has agreed to an extension of the terms and conditions of said contract, and Florida CDI, LLC/Christmas Designers, Inc., acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, Florida CDI, LLC/Christmas Designers, Inc. provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL of the Town of Palm Beach, Palm Beach County, Florida as follows:

<u>Section 1.</u> The Holiday Lighting and Decoration Services contract for a twelve-month period is hereby awarded to Florida CDI, LLC/Christmas Designers, Inc. for the amount of \$89,545.33 and establishing a project budget of \$102,980 for FY2019, contingent upon funding in the budget. The remaining extensions for the following three (3) years shall be approved only upon satisfactory performance as determined in the sole discretion of the Public Works Director for an additional amount of \$102,980 per year, for a three (3) year budget of \$308,940, contingent upon funding in future fiscal years.

<u>Section 2.</u> The Town Manager is hereby authorized to execute this contract on behalf of the Town of Palm Beach.

<u>Section 3.</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the implementation of these services, including any necessary change order work as recommended by the Public Works Director.
