## **RESOLUTION NO. 145-2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CONTRACT EXTENSION AND PURCHASE ORDER TO ALL AMERICAN SWEEPING, INC., FOR ANNUAL STREET SWEEPING SERVICES IN THE AMOUNT OF \$91,882.44, AND ESTABLISHING A PROJECT BUDGET OF \$101,070 FOR FY2019. THE REMAINING THREE YEAR PROJECT BUDGET SHALL BE \$303,210, WHICH INCLUDES AN ANNUAL COST OF \$91,882.44, AND A \$27,562.68 CONTINGENCY, CONTINGENT ON FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on September 17, 2017, to All American Sweeping, Inc. for Annual Street Sweeping Services to the Town of Palm Beach; a copy of which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, All American Sweeping, Inc. has agreed to an extension of the terms and conditions of said contract, and All American Street Sweeping, Inc. acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, All American Sweeping, Inc. provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Street Sweeping Services contract for a twelve-month period is hereby awarded to All American Sweeping, Inc. for the amount of \$91,882.44 and establishing a project budget of \$101,070 for FY2019, contingent upon funding in the budget. The remaining extensions for the following three (3) years shall be approved only upon satisfactory performance as determined in the sole discretion of the Public Works Director for an additional amount of \$101,070 per year, for a three (3) year budget of \$303,210, contingent upon funding in future fiscal years.

<u>Section 2</u>. The Town Manager is hereby authorized to execute this contract on behalf of the Town of Palm Beach.

<u>Section 3</u>. The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the implementation of these services, including any necessary change order work as recommended by the Public Works Director.
