## **RESOLUTION NO. 150-2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CONTRACT EXTENSION AND PURCHASE ORDER FOR FOUNTAIN MAINTENANCE AND REPAIR SERVICES TO MAKO POOLS IN THE AMOUNT OF \$24,200, AND ESTABLISHING A PROJECT BUDGET OF \$27,830 FOR FY2019. THE REMAINING THREE YEAR PROJECT BUDGET SHALL BE \$83,490 WHICH INCLUDES AN ANNUAL COST OF \$24,200 AND A \$10,890 CONTINGENCY, CONTINGENT ON FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on January 1, 2018, to Mako Pools, to provide Fountain Maintenance Services to the Town of Palm Beach; and

WHEREAS, Mako Pools has agreed to an extension of the terms and conditions of said contract, and Mako Pools acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, has Mako Pools, provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Fountain Maintenance Services contract for a twelve-month period is hereby awarded to Mako Pools for the amount of \$24,200, and establishing a project budget of \$27,830 for FY2019, contingent upon funding in the budget. The remaining extensions for the following three (3) years shall be approved only upon satisfactory performance as determined in the sole discretion of the Public Works Director for an additional amount of \$27,830 per year, for a three (3) year budget of \$83,490, contingent upon funding in future fiscal years.

<u>Section 2.</u> The Town Manager is hereby authorized to execute this contract extension on behalf of the Town of Palm Beach for this improvement.

<u>Section 3.</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the completion of the said project work, including any necessary change order work as recommended by the Public Works Director.
