

RESOLUTION NO. 149-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A PURCHASE ORDER TO GSKY PLANT SYSTEMS, INC., FOR THE WORTH AVENUE LIVING WALL MAINTENANCE PROGRAM IN THE AMOUNT OF \$28,900, AND ESTABLISHING A PROJECT BUDGET OF \$31,790 FOR FY2019. THE REMAINING THREE YEAR PROJECT BUDGET SHALL BE \$95,370, WHICH INCLUDES AN ANNUAL COST OF \$28,900 AND A \$8,670 CONTINGENCY, CONTINGENT OF FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on November 4, 2017, to Gsky Plant Systems, Inc., to provide Worth Avenue Living Wall Maintenance Services to the Town of Palm Beach; and

WHEREAS, Gsky Plant Services, Inc. has agreed to an extension of the terms and conditions of said contract, and Gsky Plant Services, Inc. acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, has Gsky Plant Systems, Inc., provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Maintenance Services on the Worth Avenue Living Wall contract for a twelve-month period is hereby awarded to Gsky Plant Services, Inc., for the amount of \$28,900, and establishing a project budget of \$31,790 for FY2019, contingent upon funding in the budget. The remaining extensions for the following three (3) years shall be approved only upon satisfactory performance as determined in the sole discretion of the Public Works Director for an additional amount of \$31,790 per year, for a three (3) year budget of \$113,370, contingent upon funding in future fiscal years.

Section 2. The Town Manager is hereby authorized to execute this contract extension on behalf of the Town of Palm Beach.

Section 3. The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the implementation of these services, including any necessary change order work as recommended by the Public Works Director.
