## **RESOLUTION NO. 146-2018**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A CONTRACT EXTENSION AND PURCHASE ORDER TO BATALLAN ENTERPRISES, INC. DBA PROPERTY WORKS, FOR TOWN SQUARE MAINTENANCE SERVICES, IN THE AMOUNT OF \$49,591.85, AND ESTABLISHING A PROJECT BUDGET OF \$57,030 FOR FY2019. THE REMAINING THREE YEAR PROJECT BUDGET SHALL BE \$171,090, WHICH INCLUDES AN ANNUAL COST OF \$49,591.85 AND A \$22,324.45 CONTINGENCY, CONTINGENT ON FUNDING IN FUTURE FISCAL YEARS.

WHEREAS, a contract was awarded on October 2, 2017, to Batallan Enterprises Inc. DBA Property Works, to provide Town Square Maintenance Services to the Town of Palm Beach; and

WHEREAS, Batallan Enterprises, Inc. DBA Property Works has agreed to an extension of the terms and conditions of said contract, and Batallan Enterprises, Inc., DBA Property Works acceptance is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, has Batallan Enterprises, Inc. DBA Property Works, provided acceptable service under that contract; and

WHEREAS, that contract allows for four (4) twelve-month extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Town Square Maintenance Services contract for a twelve-month period is hereby awarded to Batallan Enterprises DBA Property Works for the amount of \$49,591.85, and establishing a project budget of \$57,030 for FY2019, contingent upon funding in the budget. The remaining extensions for the following three (3) years shall be approved only upon satisfactory performance, and as determined by the sole discretion of the Public Works Director, for an additional amount of \$57,030 per year, for a three (3) year budget of \$171,090, contingent upon funding in future fiscal years.

Section 2. The Town Manager is hereby authorized to execute this contract on behalf of the Town of Palm Beach.

<u>Section 3</u>. The Town Manager, or his designee is hereby authorized to take such further actions as may be necessary to effectuate the implementation of these services, including any necessary change order work as recommended by the Public Works Director.
