- 1) BREAKDOWN SERVICE: Citation Communications will perform all repairs and required to keep the system operating at factory specifications. Repairs include all parts and labor resulting from normal usage. Service will be performed either in the field or at Citation's shop according to the agreement.
- 2) FCC RESPONSIBILITIES: As part of this agreement, Citation will maintain all required FCC records relating to technical requirements and perform all measurements and adjustments required by law. You will also be advised on the rule changes affecting your system operations.
- 3) QUALITY CONTROL: All communications systems will be maintained to full factory specifications for performance. Only quality parts are used. All service will be performed only by the most qualified, trained technicians with years of service experience.
- 4) EXCLUSIONS: Not covered by this agreement are damages caused by fire, theft, water, physical abuse or acts of God. The general intent is to cover all repairs and outages caused by normal usage. Base station antennas, transmission lines, duplexers, isolators and other items that are a part of the antenna system are also excluded from this agreement. Technicians' time on phone line malfunctions are billable after initial diagnosis of difficulty. Also excluded are pager/portable batteries, antennas, shoulder microphones, headsets, installations and removals. Units where manufacturer's parts are no longer available are exempt from repair under this contract.
- 5) PAYMENT: Invoicing will be in advance for the period to be serviced. Additions or deletions from this agreement will be per unit shown on page 1. Prices quoted are binding for a period of one year.
- 6) TERM OF AGREEMENT: The term of this agreement is one year from the effective date on the cover page, unless otherwise noted. Afterwards, contract will automatically renew, but may be terminated by either party with 30 days notice delivered by hand or certified mail.
