RESOLUTION NO. 154-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AWARDING BID NO. 2018-50 AND APPROVING A CONTRACT AND PURCHASE ORDERS TO ADVANCED DISPOSAL SERVICES SOLID WASTE SOUTHEAST, INC., FOR COMPACTED GARBAGE COLLECTION, IN THE AMOUNT OF \$315,411.41, AND ESTABLISHING A PROJECT BUDGET OF \$318,000 FOR FY2019. THE REMAINING EXTENSIONS FOR THE FOLLOWING FOUR YEARS SHALL BE APPROVED ONLY UPON SATISFACTORY PERFORMANCE AS DETERMINED AT THE SOLE DISCRETION OF THE PUBLIC WORKS DIRECTOR FOR AN ADDITIONAL AMOUNT OF THE PREVIOUS YEAR, AN ANNUAL ESCALATOR WILL BE NEGOTIATED EACH YEAR PRIOR TO RENEWAL FOR A FOUR YEAR BUDGET OF \$1,742,847.13, CONTINGENT UPON FUNDING IN FUTURE FISCAL YEARS.

BE IT RESOLVED BY THE TOWN OF COUNCIL of the Town of Palm Beach, Palm Beach County, Florida as follows:

Section 1. The compacted garbage collection contract for a twelve-month period is hereby awarded to Advanced Disposal Services Solid Waste Southeast, Inc., for the amount of \$315,411.41, and establishing a project budget of \$318,000 for FY2019, contingent upon funding in the budget. The remaining extensions for the following four (4) years shall be approved only upon satisfactory performance, as determined at the sole discretion of the Public Works Director for an additional amount of the previous year, an annual escalator will be negotiated each year prior to renewal for a four (4) year budget of \$1,742,847.13, contingent upon funding in future fiscal years.

<u>Section 2.</u> The Town Manager is hereby authorized to execute a contract on behalf of the Town of Palm Beach for compacted garbage collection.

<u>Section 3.</u> The Town Manager, or his designee, is hereby authorized to take such further actions as may be necessary to effectuate the completion of the said contracted work, including any necessary change order work as recommended by the Public Works Director.
