

RESOLUTION NO. 167-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING AND APPROVING A PURCHASE ORDER TO SEACOAST EMBROIDERY, INC. DBA SEACOAST UNIFORMS IN THE AMOUNT OF \$35,000 FOR FISCAL YEAR 2019 FOR THE PURCHASE OF POLICE DEPARTMENT UNIFORMS AND ACCESSORIES; ALLOWING FOR AN OVERALL BUDGET OF \$46,000 SUBJECT TO APPROVAL OF THE FY2019 BUDGET; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

WHEREAS, pursuant to Resolution No. 079-207 dated June 13, 2017, the Town awarded a bid to Seacoast Embroidery, Inc. d/b/a Seacoast Uniforms for the purchase of police department personnel uniforms and accessories, a copy of which is on file with the Purchasing Division of the Town of Palm Beach; and

WHEREAS, the contract was issued for a twelve-month period and provided the Town with the option to renew the contract for four additional twelve-month periods; and

WHEREAS, Seacoast Uniforms has provided acceptable service under the contract; and

WHEREAS, Seacoast Uniforms has agreed to an extension of the terms and conditions of the contract, which agreement is on file with the Purchasing Division of the Town of Palm Beach.

NOW, THEREFORE, be it resolved by the Town Council of the Town of Palm Beach, Palm Beach County, Florida, as follows:

Section 1. The Town Council of the Town of Palm Beach hereby approves a purchase order to Seacoast Embroidery, Inc. d/b/a Seacoast Uniforms in the amount of \$35,000 for the purchase of uniforms and accessories for police department staff allowing for an overall budget of \$46,000 for FY2019, subject to approval of the FY2019 budget. The remaining extensions for the following three years shall be approved upon satisfactory performance as determined in the sole discretion of the Town's Chief of Police, or designee, for an additional amount of \$46,000 per year, contingent upon approval of the budget in each of those successive years.

Section 2. The Town Manager, or his designee, is hereby authorized to execute all documents necessary to effectuate this purchase order, including any change orders as recommended by the Chief of Police or designee.

Section 3. This Resolution shall become effective immediately upon passage.

PASSED AND ADOPTED in a regular, adjourned session of the Town Council of the Town of Palm Beach this 13th day of September, 2018.
