KNOW ALL MEN BY THESE PRESENTS, that MICHAEL SHOLTZ, and ANNIE SHOLTZ, his wife, the owners in fee simple of the tract of land shown on the attached plat as "EL PARAISO" and more particularly described as follows:
Containing of a part, defined by the line of the County Road to the land set out and in use, said part being Sixty and Sixty-two and Six Hundredths (66.62) Acres of the section line between Section Eleven (11) and Section Fourteen (14) Township Forty Three (43) South, Range Forty Three (43) East, for a part of beginning, thence run Westwardly in a line of Eighty-one degrees and Forty-four (81.44) degrees measured from South to West with the center line of the County Road at ground, a distance of One Hundred and Eighty-two and Sixty-two and Six Hundredths (182.6262) to a concrete monument, thence run Southwardly on a line making an angle of Ninety degrees and no minutes (90.00) measured from West to South, a distance of One Hundred and Eighty-two and Sixty-two and Six Hundredths (182.6262) to a concrete monument, thence run Eastwardly on a line making an angle of Ninety degrees and no minutes (90.00) measured from North to East a distance of One Hundred and Sixty and Sixty-two and Six Hundredths (166.6262) to a point defined by an iron pin in the center line of the said County Road, thence run Northwardly along the said center line making an angle of Ninety-eight degrees and Twenty minutes (98.20) measured from West to North a distance of One Hundred and Fifty-one and Sixty-four (151.64) to the point of beginning, excepting from the above described tract the Easterly portion of a tract conveyed by Maurice D. Freeman and recorded in Book 167, Page 292 of Public Records of Palm Beach County, all of the above mentioned angles are included within the tract herein described have caused the same to be surveyed and plotted as shown on the attached plat, and do hereby dedicate to the perpetual use of the public the driving shown on the attached plat, roadway, drainage, utility lines, sewer, electric, gas, water or any other lines, and the easement or easements therefor, whenever the same shall be abandoned by the public or discontinued by law.

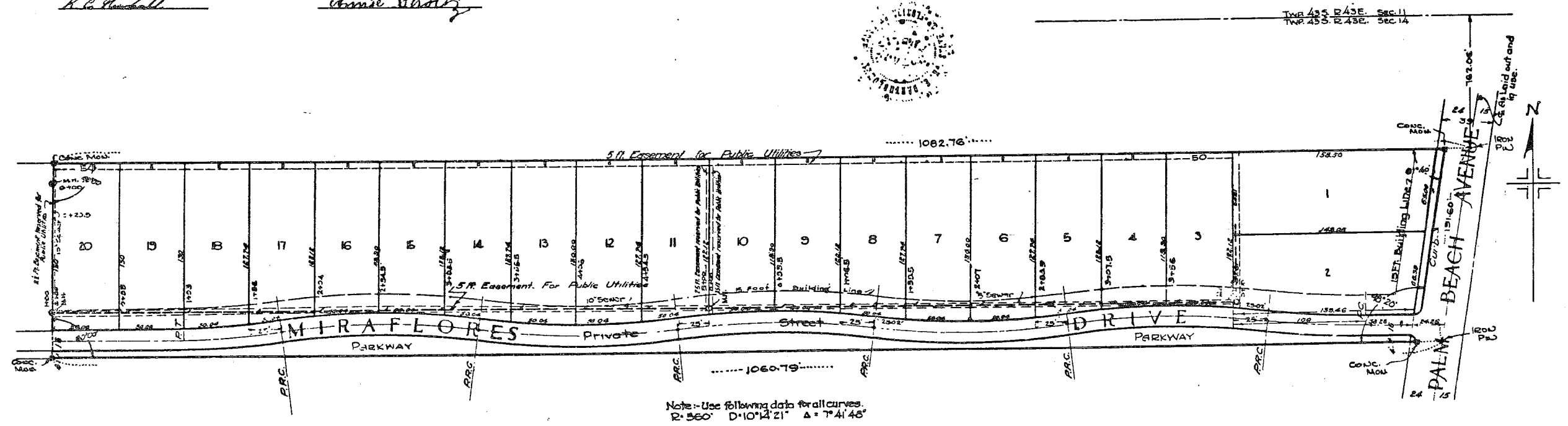
