A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, **APPROVING** THE **SELECTION COMMITTEE RECOMMENDATION FOR RFP NO.** 2018-55, FOR **TEMPORARY PERSONNEL SERVICES TO FANEUIL INC.** AS THE PRIMARY VENDOR AND HOWROYD-WRIGHT **EMPLOYMENT** AGENCY, INC. DBA **APPLEONE** AS EMPLOYMENT SERVICES THE **SECONDARY** VENDOR AND ESTABLISHING A PROJECT BUDGET OF \$150,000.00 FOR FY2019. THE REMAINING EXTENSIONS FOR THE FOLLOWING FOUR YEARS SHALL BE UPON APPROVED ONLY SATISFACTORY PERFORMANCE AS DETERMINED AT THE DISCRETION OF THE HUMAN RESOURCE **DIRECTOR AND THE** PURCHASING MANAGER FOR A FIVE YEAR CONTRACT **BUDGET OF \$828,843.00 CONTINGENT UPON FUNDING IN** FUTURE FISCAL YEARS.

WHEREAS; Purchasing issued Request for Proposal (RFP) 2018-55 for Temporary Personnel Services. The previous solicitation was issued in 2013 for a five year period and;

WHEREAS; Fourteen firms responded to the solicitation of which the Selection Committee reviewed and ranked all submittals. The Selection Committee ranked Faneuil Inc. as the Primary Awarded Vendor and Howroyd-Wright Employment Agency, Inc. dba AppleOne Employment Services as the Secondary Awarded Vendor, and;

WHEREAS; Town Council approval is sought to approve the Selection Committee Recommendation in the amount at \$150,000.00 for FY2019. The projected five year award is \$828,843.00 contingent upon funding by the approved budgets.

NOW, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

<u>Section 1.</u> The Town Council recommendation of the Selection Committee is hereby approved.
