RESOLUTION NO. 192-2018

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AWARDING BID NO. 2018-54 AND APPROVING A CONTRACT AND PURCHASE ORDERS TO JOHN CASSIDY, FOR HVAC, MAINTENANCE SERVICES, **COMMERCIAL** REFRIGERATION, FREEZERS, REPLACEMENT UNITS AND RELATED PARTS, AND ESTABLISHING A PROJECT BUDGET OF \$121,225 FOR FY2019. THE REMAINING EXTENSIONS FOR THE FOLLOWING FOUR YEARS SHALL BE APPROVED ONLY UPON SATISFACTORY **PERFORMANCE** DETERMINED AT THE DISCRETION OF THE PUBLIC WORKS DIRECTOR AND THE PURCHASING MANAGER FOR A FIVE YEAR CONTRACT BUDGET OF \$675,165, CONTINGENT UPON FUNDING IN FUTURE FISCAL YEARS.

WHEREAS; The Town solicited a Bid for HVAC, Maintenance Services, Commercial Refrigeration, Freezers, Ice Machines, Replacement Units and Related Parts, and;

WHEREAS; Purchasing obtained six responsive and responsible bid submittals; and

WHEREAS; John Cassidy AC was found to be the responsive and responsible bidder that offered best pricing and has an excellent performance ranking of previous work with the Town; and

WHEREAS; Town Council approval is sought to approve the Bid Award and Purchase Order to John Cassidy in the amount of \$121,225 for FY2019, and establish a five year (5) year contract budget of \$675,165, contingent upon funding in future fiscal years.

NOW, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

<u>Section 1.</u> The award of Bid No. 2018-54 to John Cassidy for HVAC, Maintenance Services, Commercial Refrigeration, Freezers, Ice Machines, Replacement Units and Related Parts, is hereby approved in the amount of \$121,225 for FY2019, and establishes a five year (5) year contract budget of \$675,165, contingent upon funding in future fiscal years.

<u>Section 2.</u> The Town Manager, or his designee, is hereby authorized to take such further action as may be necessary.
