Thank you for contacting me.

I prefer an estimate so that I can use that with the Rotary Foundation for budget purposes. On July 3 we will be installing flags in two large medians for 8-9 hours. See attached. Ignore the incorrect reference to "West Palm Beach."

The attachment shows maximum median capacity based on a 5 foot grid. The grid has been changed to a 6 foot grid with up to 500 flags in the east median (Median #2) and, if needed, up to 250 flags in the west median (Median #1). The last slide shows how the flags will be displayed.

Flags are installed into a 12 inch spiked flag holder placed into the ground.
