

## **RESOLUTION NO. 12-2019**

### **A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, DECLARING THE RESULTS OF THE ELECTION HELD ON THE 12<sup>TH</sup> DAY OF MARCH, 2019.**

**WHEREAS**, the following incumbents Mayor GAIL L. CONIGLIO, and Council Member DANIELLE H. MOORE, Group 1, were duly nominated at the regular and duly called Caucus of the voters of the Town of Palm Beach, Florida, held on January 8, 2019 and were unopposed; and

**WHEREAS**, on the 12<sup>th</sup> day of March, 2019, there was held an election in the Town of Palm Beach, Palm Beach County, Florida, between the hours of 7:00 A.M. and 7:00 P.M., wherein the following names were submitted to the qualified electors of the Town of Palm Beach for the Election of Town Council Persons - Group 2, for the term of two years:

#### **TOWN COUNCIL PERSON - GROUP 2**

RENE SILVIN

**WHEREAS**, due and legal notice of said Election was given by the Proclamation of the Mayor of said Town, which said notice was duly published and posted as required by law; and

**WHEREAS**, on the 12<sup>th</sup> day of March, 2019, the Precinct Clerks, Deputies, and Inspectors of said Election, after taking and subscribing their oaths in accordance with law, did conduct said Election on said date; and

**WHEREAS**, after the closing of the polls, the votes were tabulated as provided by law, and the Palm Beach County Supervisor of Elections made her return to the Town Council, which certified that the following is the result of said Election, to wit:

#### **TOWN COUNCIL PERSON - GROUP 2**

JULIE ARASKOG	1,640 votes
RENE SILVIN	1,061 votes

1,902 VOTES WERE CAST BY THE USE OF OPTICAL SCAN VOTING MACHINES, 799 VOTES WERE CAST BY ABSENTEE BALLOT, AND 4 VOTES WERE CAST BY PROVISIONAL BALLOTS, FOR A TOTAL OF 2,705 VOTES CAST IN THE TOWN OF PALM BEACH.

**WHEREAS**, in accordance with Article III, Section 34-121, of the Town of Palm Beach Code of Ordinances, the Town Council declares the results of the Town of Palm Beach Municipal Election, upon certification by the Supervisor of Elections of Palm Beach County, that the votes cast through the Optical Scan Voting Machines, Absentee Ballots, and Provisional Ballots, are a true and correct tabulation of the said votes.

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:**

**SECTION ONE.** The foregoing recitals are hereby ratified and confirmed.

**SECTION TWO:** That the following named candidates are hereby declared to be elected to the office of Mayor, for a term of two years; Town Council Person – Group 1, for a term of two years, and Town Council Person Group 2, for a term of two years:

**TOWN COUNCIL PERSON – GROUP 1**

DANIELLE H. MOORE

**TOWN COUNCIL PERSON - GROUP 2**

JULIE K. ARASKOG

The terms of office of the elected officials referenced above shall begin from the first regular meeting of the Town Council following March 12, 2019, and shall run for a period of two years until a date subsequent to the election upon which they or their successor are sworn in and take office.
