STAFF RECOMMENDATION

Staff recommends that the Mayor and Town Council review the information provided below and provide direction to staff.

GENERAL INFORMATION

At the May 14, 2019, Town Council meeting, the first reading of Ordinance No. 25-2019 was presented for Council consideration as recommended by the Ordinances, Rules and Standards Committee.

After some discussion at the May 14 meeting and the lack of a second to the motion for approval, Ordinance No. 25-2019 was deferred to the May 15 Town Council meeting. After further discussion at the May 15 Council meeting Ordinance 25-2019 was denied but staff was directed to report to Town Council at the June 11 meeting with ideas for possibly limiting the issuance of special event permits at smaller parks.

Subsequent to the May 15 Council meeting, staff prepared a list of 16 parks/public spaces in which special event permits may be applied for and issued (not including the public beaches). Council had some discussion regarding prohibiting or limiting the issuance of permits for parks under one (1) acre. Ten (10) of the parks listed are less than 1 acre, including Phipps Plaza Park, which was the park considered for prohibition of permits in Ordinance 25-2019. Memorial Park/Fountain, which is a popular special event permit site, is also less than 1 acre. In addition to using park size as a prohibition metric, the number of participants permitted at any given location could be regulated. Therefore, here are a couple of options to consider as Council discusses if there is an interest in implementing restrictions on the issuance of special event permits.

- 1. Prohibit the issuance of permits on properties under 1 acre and directly adjacent to residential properties
- 2. Limit the number of participants to a specific amount for properties less than 1 acre
- 3. Limit the number of permits issued at any given location under an acre to certain amount per year (perhaps 1 or 2 events)
