## RESOLUTION NO. R 2018-219

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, APPROVING RENEWAL OF THE CONTRACT AWARDED TO KEMIRA WATER SOLUTIONS, INC. FOR A DISSOLVED SULFIDE REDUCTION AND ODOR CONTROL SYSTEM FOR THE UTILITIES DEPARTMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town is in need of a dissolved sulfide reduction and odor control system in its' sanitary sewer system; and

WHEREAS, the Town solicited sealed bids for such services; and

WHEREAS, the original contract term was for two (2) years with an option to extend the contract for three (3) additional two (2) year terms; and

WHEREAS, after review, the Town Council wishes to renew the contract with Kemira Water Solutions, Inc. for the third and final two (2) year renewal period.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

<u>SECTION 1.</u> The Town Council hereby renews the contract with Kemira Water Solutions, Inc. for a dissolved sulfide reduction and odor control system.

SECTION 2. This is the third and final renewal option for two (2) years beginning July 18, 2018 and ending on July 17, 2020 with all contract terms and pricing remaining unchanged.

<u>SECTION 3.</u> The Town Council hereby authorizes the expenditure from the Utilities Department Chemicals - Wastewater Account. Expenditures are dependent on usage and within established budget.
