PLANNING AND ZONING COMMISSION

The Planning and Zoning Commission acts in an advisory capacity to the Town Council in all matters relating to municipal planning and development. The Commission is required to follow the concepts and contents of the Town's comprehensive land use plan in all planning, zoning and development related deliberations and decisions. The Commission shall also have such powers and duties as may be prescribed by Ordinance. The members of the Commission must be registered voters in the Town of Palm Beach. The seven regular members serve for terms of three years. Three alternate members of the Zoning Commission may be appointed by the Town Council who serve when called upon by the Chair of the Commission in the absence of any regular member.

Dear Council Members:

I am applying for the Planning and Zoning Commission position as my term is up on September 30, 2019. I have served the Town of Palm Beach for over 16.5 years or nearly 1/3 of my life; 9 years on the Recreational Advisory Commission (3 years as Chairman) and 7.5 years on the Planning and Zoning Commission.

Albeit we have the finest Towns in the Unites States, there is still a lot of work to be done regarding Planning and Zoning. I believe we need to revisit the present zoning codes as some of the text is outdated. Other issues which have been problems in the town are as follows and I believe there are solutions to these problems.

- 1) There appears to be an excess of commercial development to service the needs of the town.
- 2) Due to this over development of commercial development, there are problems with parking and traffic congestion.
- 3) Now that the residential lots are selling for more than the commercial lots, I believe it is time to allow some redistricting of some of the commercial zoning to allow residential use as an allowable use; this would lessen the amount of parking and traffic issues and will this change will NOT be hampered by the Bert Harris Law. This will allow the developers to obtain their Highest and Best Use for the commercial lots.
- 4) I have proposed for parking garages in the past with much reluctance from the Council; as most towns and cities have parking facilities; this would take a lot of the autos off the streets.
- 5) The zoning code is outdated and a good portion of the homes (ie The Street Streets) do not conform to today's Codes. I would like to revisit the idea of Historic Districts. I helped write the new Sea Streets Ordinance regarding development which I believe will help some developers. There has been major concerns about the demolition of some the homes on these streets and it breaks my heart to see these streets being changed; especially to see new homes on Sea Spray which are out of character and raised so high above the other homes.

I want you to know that I love this town and its citizens and I would appreciate all of your support in allowing me to serve you and the people. I must commend you for your time and dedication as you have made this town "Paradise". But, I think there is plenty of work left to do.

Thank you for your support in the past and praying you will vote for me.
