***Ann Jackson's letter to Council:***

I am out of town, so can't be at meeting tomorrow, but I have written the following letter. To the Mayor, Town Council and town staff,

I am writing in regards to the proposed designation of the Seas streets as an historic district as I cannot be at the Town Council meeting tomorrow.

I have owned my house on Seaview Avenue for over 42 years. I have seen houses torn down and new ones built. On older houses I have seen historic details demolished in the name of energy efficiency and modernizing. There is very little of historic value left on the ocean block of Seaview. Creating this historic district on the Seas streets places an unnecessary burden on the residents. Furthermore it appears that it is proposed by a committee of non- residents and apartment dwellers, not house owners or even residents of the impacted area. Shame on them!

Please ignore this proposal by the Landmarks Commission and leave us in peace on the Seas streets.

**Bradford Winston's Letter to Council:**

I write to add my objection to the historic designation of the "Sea" Streets.

While I would be happy to reiterate all the reasons and provide additional support for those already suggested by others such an exercise would be redundant and likely not read in its entirety and only exorcise many of you who volunteer your time on behalf of our town.

What I would add is this matter as well as the most recent private "Club" proposal have both come before the Owners of the Sea Streets houses/cottages at a time when most of us are not occupying our homes during the "off" months despite our many pleas to hold your hearings when a greater number of us are in Palm Beach during "the season" when a matter that impacts all of us is before you. I also believe that we, the Owners of the Sea Streets houses, were not provided notice concerning this particular matter.

I would, again, as I had requested in response to the "Club" matter implore the Council members to consider the constituents impacted when putting a matter on the calendar with notice to all within 400 feet of the matter in consideration and during the season, not the shoulder months, when a majority of the residents might be present and able to provide their own input in person.

Thank you for your continued efforts and apparent support to withdraw the request by the Landmarks "Committee" and its members most of whom appear to not even be Owners of homes in Palm Beach let alone the Sea Streets.
