Ever since that time the trash has been picked up on the north side (Park Avenue) of the building. Originally the trash truck would come up the easement between the Park Avenue Inn and the house next door to get the trash from the closed trash room and refrigerated trash room (for the ballroom/kitchen).

After many years the Town changed that to have the trucks stop on Park Avenue and the dumpsters rolled down and back the easement.

At one time, perhaps about 12 years ago, there was some indication that we were not going to be allowed to have our trash picked up on Park Avenue. They said that we would have to build an enclosed trash room somewhere on the east side of our property and have the trash picked up by the east gate on Sunrise Avenue. But then we were told that we could not build something there and after consideration by the Town we were allowed to continue doing it the way it had been on Park Avenue.

As I understand it, this is the result of a few complaints made by residents living on Park Avenue.

For more than 30 years, the trash pickup at the Palm Beach Hotel Condominium has been picked up via an easement located on Park Avenue, however, recently the Town notified the property that the trash, including recycle containers, would no longer be picked up from this location, but rather the town is designating a new location located on Sunrise Avenue.



RE: Opposition to Garbage Removal from Sunsise Ave.

Dear Mayor Coniglio:

I am a permanent resident of the Palm Beach Hotel Condominium, 235 Sunrise Ave. R-3214, Palm Beach Florida. I am also a registered voter in the Town of Palm Beach. I have owned real estate in Palm Beach since 2004.

I am opposed to the removal of garbage from Sunrise Ave. I support the Association's request for continued use of a private Easement for access to the Association's dumpster. The easement was granted to the Association by the abutting owner's predecessor in title of a private residence located at 242 Park Ave.

The easement runs between the easterly sideline of 242 Park Ave. and the westerly boundary of a small public park which is .2 acres at the rear of the Hotel building. The easement is paved and of enough width for utility and municipal vehicles. The easement has been continuously utilized by the Association for access to the dumpster and removal of trash and garbage for the last twenty-five years.

Our hotel property fronts on the 200 Block of Sunrise Ave. To the rear of the hotel property is a small public park and private two-story residences. Park Ave. is a town road, one-way, restricted permitted parking on its south side. Zoning on this street is RC-1, Medium Density Residential. The homes on the street are multi-family residential. Both corners on Park Ave. are approved for business use and commercially zoned for business. There is minimal traffic on Park Ave. during peak season in Palm Beach, November thru April.

Our condominium located at 235 Sunrise Ave., is mixed use: commercial and residential. The building was erected in 1926, converted to a mixed-use condominium in 1982. It is four (4) stories, consisting of 200 small residential units and 12 commercial units fronting on Sunrise Ave. The building contains approximately 169.400 square feet of enclosed space. The Mediterranean Revival style facade gained recognition as a Palm Beach town landmark in 2008 and in National Register of Historic Places in 2015. It is an important historical resource for the town in which there are ten other landmarked buildings including the Paramount Theater, its immediate neighbor.

Per the towns Amended Comprehensive Plan of 2017, aside from the two bridges connecting Palm Beach to West Palm, the major generators of traffic in the Town are limited to the two major commercial areas. These are the northern commercial area encompassing uses on Royal Poinciana Way, Sunrise and Sunset Avenues, Bradley Place, North County Road, and the Royal Poinciana Plaza. The 200 Block where our building is located is a critical component in this mix. The other is the Town Center area which includes the retail concentrations along South County Road, Peruvian Avenue, and Worth Avenue and, the office area along Royal Palm Way.

Over the last thirty years there have been numerous studies made of traffic on the 200 Block of Sunrise. The block is densely retailed, is located between Bradley Place and North County with intersectional traffic lights. There are twenty small retail stores, two major restaurants with valet parking, the Biltmore Gallery retail complex, and the Publix Supermarket and Saint Edwards Church on both ends of Sunrise. Although there is private restricted off the road parking, Sunrise is heavily trafficked on a year-round basis. Peak season is between November thru April. Between 9 AM to 5 PM hourly parking is permitted on both sides of the street. The calculations shown in Table 13 of the towns Parking Improvement Study based on the square footage of building space at 235 Sunrise states that the block is deficient by 22 parking spaces. The block is serviced by public buses Route No. 41 with a bus stop between the Biltmore Galleria and Chase Bank. Sunrise Ave., per the town's comprehensive planning documents which state that Sunrise is included in one of only two Recreational Park Service Areas recommended by the town planners.

The removal and collection of garbage in numerous barrels by large utility sanitation vehicles from the 200 block of Sunrise not only over burdens an area with heavy year-round traffic counts, limited parking and congested businesses but creates blight offensive to our immediate neighbors. Requiring the Association to unload garbage on a street that is critical to the future park and recreational plans proposed by the towns comprehensive plan is folly. Utilizing the Associations rear access from Park Ave. has no impact on one of the town's most critical access roads. As such, I urge the town to permit the Association's continued removal of garbage from its dumpster over its easement access on Park Ave.

The storage and pickup location has been from Park Avenue for at least the last 30+/- years at the town-approved designated area. It is not reasonable to change this location due to a couple of complaints from fellow citizens who only have self-serving interest and not the good of the community in mind.

Recently you enacted parking limitations and road direction changes to our section of the town; when I asked at city hall about this program, I was informed that Sunrise and Sunset Avenues are a very important streets for the commercial business's in the town. This action seems to be counter to that mandate and the changes to traffic and parking that were made to support the business community.

The adverse effect this action will have on the business in this section town is untold but will not be positive. 
