GENERAL INFORMATION

The Town of Palm Beach is seeking proposals from qualified contractors for the Treatment for Lethal Yellowing Disease, Royal Palm Bug Treatment and Fertilization of Royal Palms.

The awarded contractor shall provide all necessary labor, management, supervision, trucks, gas, oil, safety equipment, and any other materials and equipment necessary to inject each of the estimated 2,382 Town-owned coconut palms and single-trunked date palm varieties three times per year, and apply an Imidicloprid-based insecticide for control of Royal Palm Bug twice per year & fertilizer applications three-times per year to each of the estimated 550 Royal Palms on Town-owned properties and Right-of-Ways.

All treatments may occur concurrent or sequentially to one another without more than two-days stoppage between normally scheduled working days and hours. Each treatment series shall be performed and completed within the specific months indicated. The Town desires that all services are performed in February, June and October of each year.
