The Bond shall not be or constitute an indebtedness of the Town, Palm Beach County, Florida, the State of Florida or any political subdivision thereof within the meaning of any constitutional, statutory or other limitation of indebtedness, but shall be a revenue bond payable from legally available non-ad valorem revenues of the Town that the Town covenants to budget and appropriate in each fiscal year to pay debt service on the Bond.
