RE: Resolution to Approve **Resolution No. 100-2020**, A Resolution authorizing a

purchase order to Florida Superior Sand, Inc. to furnish and deliver sand to PAR 3 in the Amount of \$12,000 for FY21 and \$12,00 for water crushed shell for FY21. The total recommended for this awarded contract will be \$89,405 which include

FY17, FY18, FY19 and FY20 previously awarded purchase orders.

STAFF RECOMMENDATION

Town staff recommends that Town Council approve Resolution No. 100-2020. When the original solicitation was issued in 2017, solicitations were addressed to Town Council for one Fiscal Year and only if it met the Town Manager's award authority. Since the original award, the Town has issued purchase orders for FY17, FY18, FY19 and FY20 in the total amount of \$65,405.

The award for FY21, will now exceed the Town Manager's approval threshold due to the requested and approved budget amount of \$12,000 for continued services. The new total expenditure for this service will be \$89,405 by September 30, 2021.

It should be noted that this item is being presented to Town Council as Purchasing is reviewing all contracts to ensure full compliance with Town Policy and Procedures. Since this was an older contract, it was identified during our internal review of awarded contracts.

WHY THE SERVICE IS REQUIRED

Sand is required to support the PAR 3 operations. The following represents deliverables for the golf course:

- ➤ There are 13 sand traps on the golf course. It takes 75 tons of bunker sand to replenish annually.
- ➤ On an annual basis, 100-175 tons of green sand is used for divot filling and topdressing greens.
- ➤ 150-250 tons of 100% USGA specification topdressing sand, mostly for top dressing greens and tees.
- ➤ 250-350 tons of washed crushed shell to replenish the cart paths and flower beds done annually.

> 20 tons of sand injected into the greens

HOW SERVICE WAS SOLICITATED

Town Purchasing issued RFQ 02-2017 in August 2017. Florida Superior Sand was awarded the contract. This the last year of this contract and will be re-solicited.

PERFORMACE SINCE AWARD DATE

The Town has had satisfactory performance from the vendor.

FUNDING/FISCAL IMPACT

Funding for this service will be from the Recreation expense budget.

RECREATION REVIEW

This item has been reviewed by the Recreation and approved as recommended.

TOWN ATTORNEY REVIEW
