

Ordinance No. 19-2020

AN EMERGENCY ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA. RESCINDING IN ITS ENTIRETY ORDINANCE NUMBER 15-2020 WHICH INCLUDED THE PUBLIC BEACH FROM WELLS ROAD SOUTH TO SUNSET AVENUE AS AN ADDITIONAL BEACH DECLARED TO BE CLOSED TO THE PUBLIC EACH DAY FROM SUNSET TO SUNRISE; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR CODIFICATION; PROVIDING AN EFFECTIVE DATE

**WHEREAS**, upon review the Town Council has deemed it inappropriate for the area from Wells Road to Sunset Avenue to be included within the restrictions related to beach closures within those areas defined within Section 74-196 of Division 3 of Chapter 74 of the Town's code of ordinances; and

**WHEREAS**, the Town wishes to immediately rescind the restriction relating to beach closure relating to the area from Wells Road south to Sunset Avenue.

**NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:**

Section 1. Ordinance Number 15-2020 is hereby rescinded in its entirety immediately upon adoption of this Ordinance on first reading as an emergency ordinance.

Section 2. If any provision of this Ordinance or the application thereof is held invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid provisions or applications, and to this end the provisions of this Ordinance are hereby declared severable.

Section 3. All ordinances in conflict with this ordinance are hereby repealed.

Section 4. This ordinance shall be codified as provided by law.

This ordinance is effective this 9<sup>th</sup> day of December, 2020 as an emergency ordinance upon its first and only reading.
