Good morning Ms. Ziska,

I am the property owner at 424 Brazilian, next to Ronald Gross' property at 420 Brazilian. You have recently filed a zoning variance on his behalf for the purchase of 400' of property at 429 Australian to be used for a generator.

The location map attached to the notification of neighbors was not specific enough to indicate where the 400' of property is located relative to the southern border of Mr. Gross' property, nor therefore, where the generator would be placed.

As this application will be heard at the February 10th, 2021 meeting of the Town Council and these notifications were received by the neighbors only this past Saturday, February 6th, please provide as soon as you can by email a very specific survey showing where the generator will be placed.
