As you know, the Simmons' Appeal was deferred to the Town Council Meeting of April 14, 2021. I would like to request another deferral to the May Town Council Meeting. All of the zoning approvals that were part of the settlement have been granted by the Town Council and ARCOM, and the only remaining items that need to occur before the Simmons' Appeal is withdrawn is:
