

RESOLUTION NO. 072-2021

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, PROVIDING FOR THE DESIGNATION OF TEN (10) ADDITIONAL TREES AS HISTORIC AND SPECIMEN TREES IN LAKE DRIVE PARK, PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 126-57 of the Town Code of Ordinances relating to preservation of historic and specimen trees, procedures are outlined for the designation of certain trees as historic or specimen trees; and

WHEREAS, the Town Council of the Town of Palm Beach has undertaken the procedures required to designate certain trees located on properties within the Town as historic or specimen trees; and

WHEREAS, the Town Council of the Town of Palm Beach desires to record said designations in the public records of Palm Beach County, Florida, pursuant to the terms of said Ordinance.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL of the Town of Palm Beach, Palm Beach County, Florida, as follows:

Section 1. Tree #285 a Hong Kong Orchard (botanical name: Bauhinia Blakeana) shall be added as a historic or specimen tree and recorded with the Palm Beach County Clerk:

320 South Lake Drive (PCN/Legal: 50-43-43-23-05-020-0010)

<u>Count</u>	<u>Common Name</u>	<u>Botanical Name</u>
1	Hong Kong Orchard	Bauhinia Blakeana

Section 2. Tree #'s 288 thru 293 Lofty Fig (botanical name: Ficus Altissima) shall be added as historic or specimen trees and recorded with the Palm Beach County Clerk:

320 South Lake Drive (PCN/Legal: 50-43-43-23-05-020-0010)

<u>Count</u>	<u>Common Name</u>	<u>Botanical Name</u>
6	Lofty Fig	Ficus Altissima

Section 3. Tree #294 a Ficus Medium Leaf (botanical name: Ficus SPP) shall be added as a historic or specimen tree and recorded with the Palm Beach County Clerk:

320 South Lake Drive (PCN/Legal: 50-43-43-23-05-020-0010)

<u>Count</u>	<u>Common Name</u>	<u>Botanical Name</u>
1	Ficus Medium Leaf	Ficus SPP

Section 4. Tree #296 a Pink Tabebuia (botanical name: Tabebuia Heterophylla) shall be added as historic or specimen tree and recorded with the Palm Beach County Clerk:

320 South Lake Drive (PCN/Legal: 50-43-43-23-05-020-0010)

<u>Count</u>	<u>Common Name</u>	<u>Botanical Name</u>
1	Pink Tabebuia	Tabebuia Heterophylla

Section 5. Tree #299 an Orange Geiger (botanical name: Cordia Sebestena) shall be added as a historic or specimen tree and recorded with the Palm Beach County Clerk:

320 South Lake Drive (PCN/Legal: 50-43-43-23-05-020-0010)

<u>Count</u>	<u>Common Name</u>	<u>Botanical Name</u>
1	Orange Geiger	Cordia Sebestena

Section 6. This Resolution shall become effective upon its adoption as provided by law.
