## **STAFF RECOMMENDATION**

It is recommended that Town Council review the information below and provide feedback relative to the size and ratio of regular vs. alternate members of ARCOM, LPC, and P&Z commissions.

# **GENERAL INFORMATION**

At the December 8, 2020, Town Council meeting, staff presented recommendations for modifying the size of certain boards and commissions, including the ratio of regular vs. alternate members. In addition to staff's recommendations, Council gave consideration to the feedback received from the boards and commissions in question. Below is a summary of what the Council was provided at that time to inform their decision.

### **Architectural Commission (ARCOM)**

Current Make-up: 10 members (7 regular and 3 alternates)

Current Vacancies: 0 vacancies

Staff Recommendation: 7 members (5 regular and 2 alternates)

Commission Preference: NO CHANGE

#### **Landmarks Preservation Commission**

Current Make-up: 10 members (7 regular and 3 alternates)

Current Vacancies: 0 vacancies

Staff Recommendation: 7 members (5 regular and 2 alternates)

Commission Preference: NO CHANGE

## **Planning & Zoning Commission**

Current Make-up: 10 members (7 regular and 3 alternates)

Current Vacancies: 2 alternates

Staff Recommendation: 7 members (5 regular and 2 alternates)

Commission Preference: NO CHANGE

## **Recreation Advisory Commission**

Current Make-up: 10 members (7 regular and 3 alternates)

Current Vacancies: 1 regular and 1 alternate

Staff Recommendation: 7 members (7 regular and 0 alternates)
Commission Preference: 7 members (7 regular and 0 alternates)

## **Shore Protection Board**

Current Make-up: 10 members (7 regular and 3 alternates)

Current Vacancies: 2 regular and 1 alternate

Staff Recommendation: 5 members (5 regular and 0 alternates)
Board Preference: 7 members (7 regular and 0 alternates)

After a lengthy discussion, Council approved moving forward with the preferences of each board, which was no change for ARCOM, Landmarks, and the Planning & Zoning Commission, and the reduction of members of the Recreation and Shore Protection Boards to 7 regular members only (no alternates).

With another round of commission term expirations approaching, the Council's further review and input regarding staff's December 2020 recommendations regarding changes in size and ratio of regular vs. alternate members is requested. Information related to board/commission sizes in certain benchmark communities has been provided below to help inform your discussion.
