

RECREATION ADVISORY COMMISSION

The Recreation Advisory Commission consists of seven members serving three year terms, appointed by the Town Council. Members of the Commission shall possess a knowledge or interest in Town recreation programs and facilities. Each member of the Recreation Advisory Commission is required to be a registered voter in the Town. The Commission acts in an advisory capacity and shall make recommendations to the Town Council on matters relating to Town recreation programs and facilities. Preference is given to candidates who are enrolled or have their children enrolled in a Recreation Department program or are a regular participant or volunteer at a Town Recreation Department facility. Three alternate members may be appointed by the Town Council who shall serve when called upon by the Chair in the absence of any regular member.

The Recreation Advisory Commission meets six times per year. Meetings begin at 9:00 a.m. and are held in the Town Council Chambers located on the second floor of Town Hall at 360 South County Road, Palm Beach, Florida.

Henry D. "Budge" Jamison IV

Henry D. "Budge" Jamison IV was reared in Nashville, Tennessee and began his business career at Jamison Bedding and Furniture, Inc., his family's fifth generation 130-year-old manufacturing firm.

Following the sale of his family business in 1979, Budge founded Jamison Research, Inc. to develop the nation's first comprehensive commercial property information service similar to the residential Multi-Listing Service (MLS) but for commercial properties.



The company established multiple interrelated databases throughout major metropolitan areas and delivered its data and updates electronically to its clients through a proprietary intranet system — a full decade before the advent of the Internet. In 1999, Jamison Research was sold to CoStar Group (NASDAQ: CSGP) and Budge retired after twenty-one years in the commercial real estate information business.

Budge has been active in the Palm Beach County area as a former 10-year volunteer Rec Center soccer coach and as a former 2-term board member of the Town of Palm Beach Recreation Commission. He is a former Trustee and President of the non-profit Palm Beach Tennis Association, former Vice-Chairman of the Board of the North Palm Beach and Florida Region of the Young Life Christian youth organization, former 12-year member of the Salvation Army's Advisory Board serving as its Chairman for the past 6 years, and former Board Member and staff photographer at the Palm Beach Zoo.

Budge is an avid photographer, backpacker, fisherman, SCUBA diver, and tennis player. He and his wife Candy Lees Jamison, a Palm Beach native, are 21-year residents of Palm Beach. They have been married for 35 years and have 3 children, Maggie, Henry, and Ellie. Candy is Counseling Therapist at Palm Beach Atlantic University.
