## **STAFF RECOMMENDATION**

Town staff recommends that Town Council approve Resolution 075-2022, approving a purchase order to Kimley-Horn and Associates, Inc. for the Town-wide Undergrounding of Utilities Project, Phase 6 North Construction Phase Services in the amount of \$344,177 and establish a project budget of \$395,800.

Town staff recommends that Town Council approve Resolution 076-2022, approving a purchase order to Kimley-Horn and Associates, Inc. for the Town-wide Undergrounding of Utilities Project, Phase 6 South Construction Phase Services in the Amount of \$344,007 and establish a project budget of \$395,600.

### **GENERAL INFORMATION**

Construction Phase Services provide the necessary engineering oversight of the construction to ensure the work is performed and completed according to design. These services not only include weekly site inspections, but also review of all invoices, review of request for change orders, review of shop drawings, testing reports, and other tasks associated with engineering interpretation of construction plans. Finally, these services review and approve as-built plans, along with substantial completion request, and final walk through of the construction project. These services provide Town staff with the necessary expertise and staffing to ensure that the final construction project meets the needs and standards of the Town.

### PROCUREMENT METHODOGLY

Town Purchasing secured the Kimley-Horn and Associates, Inc. proposal for Phase 6 North and South construction which was vetted by Town staff.

### FUNDING/FISCAL IMPACT

Funding for this award will be from the Town-wide Underground Utility Fund.
