## **STAFF RECOMMENDATION**

Town staff recommends that Town Council Approve the Award of ITB No. 2022-12, North Ocean Seawall Repair and Painting to Lambert Brothers Inc. in the Amount of \$229,700 and Establish a Project Budget of \$264,155.

## **GENERAL INFORMATION**

The Town sought bids from responsible and experienced contractors to clean, prep and paint/seal the Town's North Ocean Boulevard seawall located north of Country Club Road and south Bahama Lane directly across from the Palm Beach Country Club. Length of Seawall is approximately 1750 LF.

The purpose of the work is to restore and repair deteriorated and damaged elements of the North Ocean Boulevard Sewall identified by KHA as part of the Town's regular maintenance of its infrastructure. The North Ocean Seawall was reconstructed in the summer of 2015. Because the seawall is exposed to a harsh environment regularly: storms, hurricanes, salt air, waves, therefore should be inspected regularly to address any cracking, spalling, and recoating as part of general maintenance to extend the life of the seawall.

The project components included but were not limited to mobilization/demobilization, general conditions, bonds, insurance, pre-construction videos, permit compliance, maintenance of traffic, temporary/construction fencing, site prep and cleaning, cleaning of wall, parapet and caps, crack repairs, removal of spalling concrete, concrete repairs, containment of concrete debris, painting and sealing of all surfaces.

#### PURCHASING BACKUP

Town Purchasing advertised this project nationally through DemandStar to 289 firms. The solicitation was also advertised through the Town website and the Palm Beach Post. The solicitation was advertised for thirty days. Five firms responded to the ITB. One bid was

considered non-responsive.

Town Purchasing has conducted reference checks for the recommended awardee, Lambert Brothers, Inc.

Funding for this award will be from the Coastal Program.
