STAFF RECOMMENDATION

Town staff recommends that Town Council Approve the Award of RFQ No. 2022-17, Architectural Services to Bridges, Marsh & Associates, Inc., CPZ Architects Inc., and PGAL Inc. for a Five-Year Contract Contingent Upon Satisfactory Performance.

GENERAL INFORMATION

The existing contract for Architectural Services has no additional options for renewal. The Public Works Department indicated a continued use for these services.

Anticipated work includes providing Architectural Services for the recently awarded Engineering Study of the Town Facilities in addition to other projects as they may arise. Entering into a contract with a consultant does not obligate the Town to issue any purchase orders with the successful consultant.

PROCUREMENT AND CONTRACT BACKUP

Town Procurement and Contracts advertised this project nationally through DemandStar to 1,143 firms. The solicitation was also advertised through the Town website and the Palm Beach Post. The solicitation was advertised for thirty days. Five firms responded to the RFP.
