Minutes of the Special Town Council Meeting Held on July 13, 2022

I. CALL TO ORDER AND ROLL CALL

The Special Closed Door Town Council Meeting was called to order July 13, 2022 at 5:38 p.m. On roll call, all elected officials were found to be present, except for Council Members Araskog and Crampton. Council Member Crampton arrived at 5:39 p.m.
