Re: Request for Design Review Approval of 515 N. Lake Way, in Palm Beach, Florida.

Dear ARCOM Board Members and Town Council Members,

The applicant for this property is 515 N Lake Way LLC and the Design Professional is Richard Franklin Sammons.

Let this letter serve as the intent in support of the owner's and applicant's request for ARCOM (Architectural Review Committee) approval for the changes to the existing single-family residence located at 515 N. Lake Way, in Palm Beach.

The changes are as follows:

- (1) Additions (second story) and renovations to the existing one-story residence. The current square footage of the house is 3,867 Sq. ft. (31.97% lot coverage) and the proposed square footage of the house 5,279 sq. ft. (22.63% lot coverage). The lot coverage is reduced by eliminating the portion of the footprint of the existing house. Current cubic content of the exiting house is 34,803 cu. ft. (2.88 ratio) and the proposed cubic content of the house will be 53,377 cu. ft. (4.41 ratio)
- (2) Hardscape and Landscape Improvements, including a new swimming pool, side walls, retaining walls, and elevating the grade of the lot to meet the current FEMA elevation requirements.
- (3) Corresponding variance(s) request to be spelled out by the representing attorney, Maura Ziska (see attorneys list of variances):



- a. SPECIAL EXCEPTION WITH SITE PLAN REVIEW: For demolition of more than 50% of structure on a lot nonconforming in depth in the RB zoning district.
- Variance #1: Second story front yard setback of 24.5 feet in lieu of the 30 feet required (N Lake Way).
- c. Variance #2: Cubic Content Ratio of 4.41 in lieu of the 2.88 existing and 3.98 maximum allowed.

All architectural changes to match the English Regency character of the existing residence.

I ask for your support and your vote in favor of this application so that we may proceed with the building permit and construction phases for the changes. We ask the ARCOM Board Members and the Town Council Members to approve the application as submitted.
