

**RESOLUTION NO. 110-2022**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN  
OF PALM BEACH, PALM BEACH COUNTY, FLORIDA,  
AMENDING THE TOWN OF PALM BEACH MASTER FEE  
SCHEDULE BY MODIFYING PARKING PLACARD AND  
PAID PARKING FEES, AND PROVIDING AN EFFECTIVE  
DATE.**

WHEREAS; the Town Council has adopted the Town of Palm Beach Master Fee Schedule,  
and;

WHEREAS; Town staff has proposed revisions to the fees relating to parking placard  
program and paid parking spaces, and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN  
OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

Section 1. The Master Fee Schedule for parking placards shall be revised to read as  
follows:

**1 Month Placard**  
\$165

**6 Month Placard**  
\$777

**4 Month Placard**  
\$554

**12 Month Placard**  
\$1,454

Section 2. The Mater Fee Schedule for paid parking spaces shall be revised to read as  
follows:

**Bradley Place (100 Block)**  
\$5/hour

**Royal Palm Way (100 Block)**  
\$7/hour

**Royal Palm Way/Recreation Center Lot**  
\$3/hour (NO CHANGE)

**North County (100, 200 & 300 Blocks)**  
\$7/hour

**Peruvian (200 and 300 Blocks)**  
\$5/hour

**Sunrise (100 Block)**  
\$7/hour

**Phipps Ocean Park (South Lot)**  
\$5/hour

**Phipps Ocean Park (North Lot)**  
\$5/hour

**South Ocean Blvd (Mid-Town Beach)**  
\$7/hour

**100 Blocks of Brazilian, Australian,  
Chilean, Peruvian and Hammon**  
\$7/hour

**South Lake Drive (Adjacent to Marina)**  
Eliminate

Section 3. The adopted fees shall become effective on November 1, 2022.
