I am the Director of Events at MorseLife Health System and I am writing to you today to see if you would consider waiving the restriction of having only two charitable events in the Town of Palm Beach in one calendar year. We would be requesting this as a one-time exception for this year only.


We historically have two events each year in Palm Beach. The first event is our Dinner Dance Gala at The Breakers which is always held in December. With the pandemic, we had to change our 2021 date from December to March of 2022 but we are now back to our historical December date that we have had for over 20 years. Our second event in Palm Beach is either our Ladies Luncheon which was historically held in February but discontinued because of the pandemic or our Golf Tournament at The Breakers which is traditionally held the last Monday in March. Due to these unusual circumstances resulting from the Pandemic, we technically have three events falling into this calendar year but as mentioned one was supposed to be in December 2021. We are back to our December date for the Gala — which is slated for December 17th so with that, we kindly ask that you waive this provision for this year only.

Thank you for your time and we greatly appreciate your consideration to grant us this one-time exception.

Organizations planning to conduct charitable solicitation activities in the Town of Palm Beach are <u>required</u> (Sec. 78-102) to submit the application <u>at least</u> sixty (60) days prior to the proposed effective date of the permit.
 You must submit one application per event.

A.	On page 5, the applicant's signature needs to have a witness. You may email your application. It will be date stamped the date received.
В.	A Resolution giving authority for the fund-raising event. A resolution can be signed by any single board member or the entire board. Minutes of the Board Meeting where authority was given are also acceptable.
C.	A copy of the State Registration form. The Town of Palm Beach requires a registration with the State of Florida Department of Agriculture and Consumer Services prior to engaging in any solicitation activities. Florida residents call 1-800-435-7352 for forms and further information. Out of State residents call (850)-488-2221. NOTE: Check the expiration date on your State Registration Form as these forms are renewed annually by the State of Florida.
D.	"Schedule" for last year's fund-raising activity in the Town of Palm Beach. (Items 15 & 16 on page 4 of the application) NOTE: This requirement does not apply to first time solicitations.
E.	A check in the amount to cover the permit fee and any late fees. Make checks payable to Town of Palm Beach. NOTE: FEES ARE NON-REFUNDABLE.

- If you expect to have a drawing/raffle at the charitable event, furnish a copy of Form 501 (c) (3) filed with the IRS.
- Save this application form to your local computer from the Town's website, fill it out and save it. This will save you time filling out your next application.
