

ORDINANCE NO. 004-2023

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AMENDING THE TOWN CODE OF ORDINANCES AT CHAPTER 134-ZONING, ARTICLE X. ON-STREET PARKING PERMITS, DIVISION 2., RESIDENTIAL DISTRICTS AT SECTION 134-2291. FINDINGS; SECTION 134-2292. DEFINITIONS; SECTION 134-2296. ISSUANCE OF SPECIAL PARKING PERMITS UPON APPLICATION; SECTION 134-2298. UNLAWFUL ACTS AND SECTION 134-2302. REVOCATION OF DECAL/PERMIT. ALSO AMENDING DIVISION 3., RESIDENTIAL DISTRICTS ADJACENT TO COMMERCIAL DISTRICTS AT SECTION 134-2327. ISSUANCE; SECTION 134-2334. UNLAWFUL ACTS; AND SECTION 134-2336; ALL PROVIDING THAT VISITOR/SERVICE PERMITS MAY NOT BE USED ON A CONTINUAL BASIS; PROVIDING A DEFINITION OF CONTINUAL USE; AND PROVIDING FOR REVOCATION OF DECAL/PERMIT BY CHIEF OF POLICE FOR VIOLATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF ORDINANCES IN CONFLICT; PROVIDING FOR CODIFICATION; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PALM BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

Section 1. Chapter 134-Zoning, Article X. On-Street Parking Permits is hereby amended at Division 2., Residential Districts, Sections 134-2291, 134-2292, 134-2296, 134-2298 and 134-2302 and at Division 3., Residential Districts Adjacent to Commercial Districts at Section 134-2327, 134-2334 and 134-2336 in the manner and form attached.

Section 2. Severability.

If any provision of this Ordinance or the application thereof is held invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid provisions or applications, and to this end the provisions of this Ordinance are hereby declared severable.

Section 3. Repeal of Ordinances in Conflict.

All other ordinances of the Town of Palm Beach, Florida, or parts thereof which conflict with this or any part of this Ordinance are hereby repealed.

Section 4. Codification.

This Ordinance shall be codified and made a part of the official Code of Ordinances of the Town of Palm Beach.

Section 5. Effective Date.

This Ordinance shall take effect immediately upon its passage and approval, as provided by law.
