RE: Module III – "Codify" Proposed Work Plan/Schedule

ZoneCo and our project partners are pleased to be kicking off Module III – "Codify" on May 9, 2023. The Codify Module will begin in tandem with Module IIA – "Pre-Codify," which is scheduled to be completed by the end of June 2023.

Module III will focus on codifying all sections of the new Palm Beach Zoning Code. We will begin by codifying the zones and districts, then focus on the remaining generally applicable sections of the Zoning Code with the goal of completing a public review draft of the code by mid-November 2023.

For efficiency and maximum focus, it is our preference for the Planning & Zoning Commission and Town Council review, consider, and provide feedback and input in two monthly meetings each. The purpose of the extra meetings are for the consultant team to review the draft chapters with Planning & Zoning Commissioners and Town Councilmembers and answer their questions and receive their comments.

All drafts will be delivered to the Town 10 days in advance of the meetings. All meetings will be held in person and virtually to ensure maximum resident participation.
